MEMBERSHIP VERIFICATION – FUNERAL

There is no fee charged for a funeral of a deceased that is in good standing with St. Paul's Greek Orthodox Church. This form is to be completed to assist the Treasurer of Saint Paul's Greek Orthodox Community of Regina in determining whether such stewardship obligations have been met. The sacrament will be performed once the stewardship obligation or the sacrament fee has been paid and this form has been completed and signed by the Treasurer and returned to the Community Priest.

* * * * *

To be a member in good standing of Saint Paul's Greek Orthodox Community of Regina, the stewardship obligation for the past three years must be fully paid. The stewardship obligation is \$150 per year for single persons over the age of 18 (\$300 per year for families). The stewardship obligation will be charged retroactively for the deceased whose stewardship has lapsed, is over the age of 18 and has resided within St. Paul's Greek Orthodox Church's jurisdiction.

If the deceased is a member in good standing in another Orthodox Church, a letter from that Church's priest is required confirming that the party is a member in good standing. A sacrament fee of \$150 must be paid in full *prior* to the funeral taking place.

If the deceased is not a member in good standing of Saint Paul's Greek Orthodox Community of Regina, and is not a member in good standing in another Orthodox Church, then the funeral fee is \$450 which must be paid in full *prior* to the funeral taking place.

Please note that gratuities for the priest, chanter and/or neokoros are optional and must be handled directly with the parties involved.
