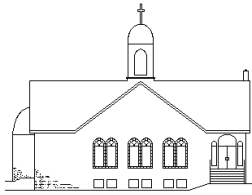

## **MEMBERSHIP VERIFICATION – SACRAMENT OF BAPTISM**

In order for the Community Priest to perform the sacrament of baptism, **all parties involved must completely fulfill their stewardship obligations prior to the sacrament of baptism taking place.** This form is to be completed to assist the Treasurer of Saint Paul's Greek Orthodox Community of Regina in determining whether such financial obligations have been met. The sacrament will not be performed unless all parties involved have fulfilled their stewardship obligations and this form has been completed and signed by the Treasurer and returned to the Community Priest.

The parents and Godparent of the child to be baptized must be members in good standing of an Orthodox Church.

To be a member in good standing of Saint Paul's Greek Orthodox Community of Regina, the stewardship obligation for the past three years must be paid in full. The stewardship obligation for families is \$300 per year (\$150 per year for a single parent). Stewardship contributions are applied retroactively for any party who's stewardship has lapsed, is over the age of 18 and has resided within the Church's jurisdiction. The stewardship obligation must be fully paid **prior** to the sacrament taking place.

In the event that the parents and Godparent are members of another Orthodox Church, they must present a signed letter from their Priest indicating that they are in good standing Ecclesiastically and up-to-date with their financial obligations towards that Church. As well, a sacrament fee of \$300 must be paid in full **prior** to the sacrament taking place.

If the parents or Godparent do not wish to become members of Saint Paul's Greek Orthodox Community of Regina and are not members in good standing of another Orthodox Church, then the financial obligation is \$900 which must be paid in full **prior** to the sacrament taking place.

The baptism of a single parent child can be performed provided that when the other parent/guardian is unable to attend the baptism service, the attending parent **MUST** provide a legal baptism consent form or a court order. The baptism consent form must be signed by the non-attending parent/guardian and co-signed by a priest, notary, or lawyer.

Please note that gratuities for the priest, chanter and/or neokoros are optional and must be handled directly with the parties involved.
