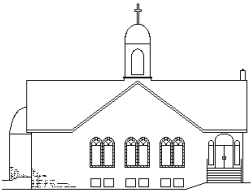

MEMBERSHIP VERIFICATION FORM FUNERAL

There is no fee charged for a funeral service of a deceased that was a member in good standing with St. Paul's Greek Orthodox Community of Regina.

This form is to be completed to assist the Treasurer of Saint Paul's Greek Orthodox Community of Regina in determining whether such stewardship obligations have been met. The Funeral Sacrament will be performed once the stewardship obligation and/or the Sacrament fee has been paid and this form has been completed and signed by the Treasurer and returned to the Community Priest.

* * * * *

To be a member in good standing of Saint Paul's Greek Orthodox Community of Regina, the stewardship obligation for the current year must be paid in full. The annual stewardship obligation is \$200 for individuals between 18 years and 64 years and \$150 per year for those 65 years and older.

For a member who has never paid or is not in good standing, is over the age of 18 years and resided within the Church's jurisdiction, a fee of \$100 will be added to the current year's stewardship obligation amount.

If the deceased is a member in good standing of another Orthodox Church, a letter from that Church's priest is required confirming that the party is a member in good standing.

If the deceased is not a member in good standing of Saint Paul's Greek Orthodox Community of Regina or is not a member in good standing of another Orthodox Church, the Funeral Sacrament fee is \$400.

The stewardship obligation and/or any Funeral Sacrament fees must be **paid in full prior** to the Funeral Sacrament taking place.

Please note that gratuities for the Community Priest, Chanter and/or Neokoros (Church Custodian) are optional and must be handled directly with the parties involved.
